4. Citizens request to address council

City Clerk Randy Pierce explained the City of Altoona received bids 13 bids on August 25th for the Terrace Hill Golf Course Club House which included a base bid, along with alternate bids. The alternate bids included 2 adds and 5 deducts. Edge Commercial submitted to low base bid at \$3,859,899. Staff and the Architect, Simonson & Associates, reviewed all of the alternate bids and have determined that it is in the best interest of the City of Altoona to reject all of the alternate bids and recommends that the City Council consider awarding the contract to Edge Commercial.
